6. UPDATING THE SML WITH A NEW SMP CERTIFICATE

In the event that a certificate update is required, the `PrepareChangeCertificate` operation described in section 6.1 will allow the user to carry out the update.

In the rare cases where the certificate is already expired, please refer to section 6.2.

6.1. `PrepareChangeCertificate` operation

The following procedure is followed while the certificate that is already registered in the SML is still valid.

In this approach SMP must call the Webservice operation `PrepareChangeCertificate` in `BDMSLSERVICEInterface` to Change the Certificates in SML on a predefined date in future.

Pre-requisites

- The current certificate of the user is a valid PEPPOL SMP certificate
- The user has the new certificate for the SMP(s)

Description

This operation allows a SMP to prepare a change of its certificate. It is typically called when an SMP has a certificate that is about to expire and already has the new one.

This operation **MUST** be called while the certificate that is already registered in the SML is still valid.

If the `migrationDate` is not empty, then the new certificate **MUST** be valid at the date provided in the `migrationDate` element. i.e. The `migrationDate` must be within `validFrom` and `validTo` dates of the new certificate

If the `migrationDate` element is empty, then the "Valid From" date is extracted from the certificate and is used as the `migrationDate`. In this case, the "Not Before" date of the certificate must be in the future.

SOAP faults

- **Fault:** unauthorizedFault - returned if the caller is not authorized to invoke the PrepareChangeCertificate operation
- **Fault:** badRequestFault - returned if
 - The supplied request does not contain consistent data
 - The new certificate is not valid at the date provided in the migrationDate element
 - The migrationDate is not in the future.
 - The migrationDate is not provided and the "Not Before" date of the new certificate is not in the future
 - The migrationDate is not provided and the "Valid From" is in the past
- **Fault:** internalErrorFault - returned if the SML service is unable to process the request for any reason

6.2. SMP with expired certificate

The following procedure must be followed to update the existing SML registrations currently linked to the certificate when the Certificate of SMP is already expired:

1. In SML Database, the existing registrations are linked to the expired certificate and these registrations need to be updated when changing certificate in order to support updates or removal of SML entries with the new certificate.
2. You need to send details for the new certificate to SUPPORT CEF-EDELIVERY-SUPPORT@ec.europa.eu and request the update for a specific time.
3. The information you need to provide is the new public certificate file, the SMP ID and the environment (Production or Acceptance).

Example:

- Attachment: Test_SMP_cer.zip
- SMP ID: Test_SMP_ID
- Environment: Acceptance(SMK)
